**Don't just whine.** Send letters to your political leaders. Copy the local newspapers. Start a legal reform group. Contact the office of the new presiding justice of the Appellate Division (in our area), Second Department Justice Alan Scheinkman.

Forty years ago, the U.S. Supreme Court cemented the Judiciary's status as above the law in *Stump v. Sparkman* in "absolute judicial immunity."

**PREPARE FOR COURT** (with or without a lawyer):

1. Consider asking for a Trial By Jury. (Must be on Notice of Claim)
2. Before you hire a lawyer or go before a judge, check them out on your computer, "Google" them, go to "E" courts, call other litigants, find out everyone's political affiliations and contributions, home address, etc., etc.
3. Contact the Ethics Commission and Grievance Committees.
4. What are their court experience? History?
5. Check political, social, business, charitable affiliations for the judge and their families.
6. Order minutes of your hearings; negotiate price.
7. Notify the Court or your lawyer in writing. ("No Backroom Conversations")
